From late antiquity to the late Middle Ages, rite and mass piety in the Byzantine Eastern and Latin Western Church were decisively influenced by the interaction of liturgical and musical practice with the sacred space. Byzantium exerted a lasting influence on church buildings in the West, especially in the architecture and the decoration with monumental gold-ground mosaics, exemplified by the Cappella Palatina in Palermo, St Mark's Basilica in Venice or the cathedrals in Perigueux and Aachen. The relationship of Byzantine to ancient Roman and Gregorian chant as well as the later development of vocal church music in East and West has increasingly become the focus of research in recent years. As several studies have shown, Byzantine sacred buildings not only responded to liturgical, ceremonial and musical requirements, but architectural innovations also affected the rite and church music. Such phenomena have also been observed in various sacred spaces in the Mediterranean regions of the Latin West.

The conference focuses on the interplay of sacred architecture, rite and music for the first time in a comparative perspective between Byzantium and the West from late antiquity to the late Middle Ages and examines transfer processes between the Byzantine Empire and the European Mediterranean region. Emphasis is placed on the sacred space in its performative function within the liturgical and ceremonial context. The guiding questions are: To what extent did synodal or conciliar resolutions and liturgical innovations in the East and the West influence the construction or modification of church buildings and modify musical composition and performance practice in sacred spaces? Which spaces were intended for musical performance and how did contemporaries perceive this? How should the relationship of monumental wall paintings or mosaics with texts and chants of liturgical celebrations be evaluated? In this context, what similarities, differences and interactions can be identified between the Byzantine Eastern and Roman Western Church?

The decidedly interdisciplinary conference is aimed at scholars of Byzantine studies, Christian archaeology and musicology, history of art and architecture, as well as liturgy and church history. The conference is organised by the research project "CANTORIA - Music and Sacred Architecture" in cooperation with the Leibniz ScienceCampus "Byzantium between Orient and Occident" (Mainz/Frankfurt) and the Leibniz Institute of European History.

Papers of 30 minutes will be accepted in German and English. Interested speakers are invited to submit an abstract of their proposed paper (max. 500 words) and a short CV (max. 300 words) by 15 May 2020 to: klaus.pietschmann@uni-mainz.de / tobias.weissmann@uni-mainz.de

Contributions by junior researchers will receive special attention. Travel and accommodation expenses will be reimbursed subject to successful financing.

With universities and libraries closing throughout the world, Byzantinists have increasingly been cut off from each other and holed up inside their residences. As Prokopios writes about the Justinianic plague, "Everyone sat at home, who were well, either caring for the sick or tending to the dying... All artists gave up their crafts and whatever else each person had in hand" (Prokopios, History of the Wars 2.23.17-8). While the world around us gives up its crafts, we as scholars in the humanities and social sciences feel the moral duty to do our best to help each other even in the isolation of self-quarantine.

For this reason, we, Scott Kennedy (Bilkent University) and Ugo Mondini (Universita' degli Studi di Milano), are putting together a reading group for scholars scattered across the world. We think that this tragic situation could be also seen as an opportunity to build solidarity among scholars and to lay the foundation for future exchanges and collaboration. Like countless other plagues before it, COVID-19 will eventually extinguish itself, but we hope that the flame of Byzantium will burn on and even grow brighter.

Reading group meetings will be conducted weekly on Sundays at 8 pm (Central European Time) in English. We kindly encourage graduate students, post-graduates, and faculty members from across the world to participate. All meetings will be conducted through Zoom, a video conferencing service. Zoom easily allows large groups to meet and break up into smaller groups for discussion. The service is free to download and use: <https://zoom.us/download>. In each meeting, we will discuss the themes and ideas present in each reading as a group. Group discussion will be moderated by either Scott or Ugo.

For this first week's theme, we will be exploring the effects of plague, war, and death on Byzantine society. Every week, we will share a poll with a few articles or chapters united by a common topic. Each week's reading will be selected in this way and then shared via email.

La lotta per l'indipendenza greca del 1821 fu la prima rivoluzione contro l'Impero Ottomano a essere coronata dal successo, e al contempo il primo sollevamento nell'Europa della Restaurazione a portare alla nascita di uno stato moderno (1832). Numerosi fattori influenzarono e favorirono l'insurrezione dei greci contro la Sublime Porta, tra cui l'influsso del neoclassicismo, teorizzato a Roma dall'archeologo e storico dell'arte Johann Joachim Winckelmann e dal pittore e teorico dell'arte Anton Raphael Mengs; la presenza di Caterina II nell'area mediterranea a partire dagli anni '70 del XVIII secolo; il trattato di Kucuk Kaynarca (1774), che promosse significativamente gli interessi greci e favorì l'ulteriore espansione e rafforzamento della diaspora in tutta Europa; la formazione di una coscienza nazionale greca ispirata ai moderni ideali dell'Illuminismo e della Rivoluzione francese; e infine l'opera di numerosi intellettuali euro-

pei e greci.

Durante la seconda meta' del XVIII secolo questi importanti sviluppi politici e culturali non passarono affatto inosservati presso la societa' europea, e condussero anzi alla nascita del movimento filellenico che, nella prima meta' del XIX secolo, ebbe un'influenza determinante non solo in tutta Europa, ma anche in una parte del continente americano.

Specialmente in Italia, il Filellenismo conobbe una grande partecipazione e una rapidissima diffusione e costitui', durante i primi decenni del XIX secolo e soprattutto a partire dal 1821, un comune punto di riferimento per molti intellettuali, artisti, letterati, storici e politici italiani. Tale fenomeno fu certamente favorito dalla vicinanza geografica, dai contatti e dalla convivenza di lunga data tra il popolo italiano e quello greco, dalle guerre napoleoniche, dagli effetti del Congresso di Vienna e da una serie di altre condizioni sociali, politiche e culturali. In molti casi, inoltre, la lotta per l'indipendenza greca fu all'origine di intensi dibattiti che stimolarono il processo di unificazione politica che condusse, nel 1861, alla creazione del Regno d'Italia. Letteratura, teatro, storia, musica, arti visive e studi sul folclore sono alcuni tra gli ambiti in cui il Filellenismo italiano lascio' tracce indelebili e creo' un patrimonio culturale che, senza mai nascondere il proprio orientamento politico, promuoveva un pensiero europeo e riconosceva il contributo della cultura greca alla formazione di una comune identita' europea.

Per queste ragioni, il convegno intende portare alla luce e studiare tutti gli aspetti del movimento filellenico italiano che presentano una stretta correlazione con la lotta greca per l'indipendenza, e in special modo quelli che consentono di sottolineare la prospettiva europea della Rivoluzione greca del 1821. Saranno ben accolte le analisi di tipo interdisciplinare, culturale e interculturale, cui l'argomento si presta in special modo, nonche' gli approcci di genere; una parte del convegno sara' inoltre dedicata alle voci femminili del Filellenismo italiano.
