An international video conference on engraved gems in the Archaic, Classical, Hellenistic, Roman and Byzantine eastern Mediterranean and Black Sea area will take place on May 13-14, 2021 on Zoom.us.

An engraved gem, frequently referred to as an intaglio or cameo, is a small and usually semiprecious gemstone that has been carved, in the ancient Greek and Roman tradition normally with images or inscriptions only on one face. The engraving of gemstones was a major luxury art form in the ancient eastern Mediterranean. Near Eastern glyptic art covers the field of small carved stones, including cylinder seals and inscriptions in archaeological contexts. Though in the Graeco-Roman Mediterranean they were keenly collected in classical antiquity, most carved gems originally functioned as seals, often mounted in a ring.

Engraved gems were found in relatively large quantities in the eastern Mediterranean and Black Sea area, where they were in use and produced frequently between the Bronze Age and Medieval periods. So far the study of these multifunctional objects has been overlooked in the eastern Mediterranean whereas there is still a huge amount of unpublished material from excavations and museums in an area from Albania down to Egypt, including Greece, Turkey and Cyprus.

Ancient engraved gems can be categorized based on different criteria, including their gemological and mineralogical material, genres of material, decoration, production, use and distribution.

In this online conference we only focus on Greek, Roman and Byzantine engraved gems from the eastern Mediterranean and Black Sea area between c. early sixth century B.C. and early seventh century A.D., and attempt to set out a comprehensive model for the study of engraved gems, including their definition, typology, chronology, contexts, function, regional characteristics and distribution patterns in the whole eastern Mediterranean and Black Sea geographies. It is also our intention to create a complete bibliography of previous publications on engraved gems.

We warmly invite contributions by scholars and graduate students from a variety of disciplines related to these objects. Intended to bring together scholars of Greek, Roman and Byzantine archaeology to discuss a range of issues concerning these instruments' characteristics, this electronic conference should be an excellent opportunity to increase our knowledge about this material. The following theme groups are the main questions of this online conference which are prescriptive:

- Engraved gems from archaeological field projects, museums and private collections,
- Ancient Greek and Latin textual sources on engraved gems,
- Evolution of engraved gems in the eastern Mediterranean and Black Sea area during the Archaic, Classical, Hellenistic, Roman and Byzantine periods,
- Similar instruments in the ancient Near East and their relations to ancient Graeco-Roman gems,
- What ancient Greeks and Romans thought about afterlife? Engraved gems in funerary and votive contexts,
- Domestic and commercial use of engraved gems,

- Magical gems,
- Related instruments to engraved gems in the regards of their function,
- Decoration, iconography and epigraphy at engraved gems in Greek, Roman and Byzantine periods,
- Major production centers of engraved gems in the eastern Mediterranean and Black Sea,
- Signatures at engraved gems,
- Byzantine engraved gems in religious contexts,
- Miscellanea.

On these themes and questions, all disciplines, approaches and methods susceptible to bring some progress to our current knowledge are of course welcome: classical archaeology, Byzantine archaeology, gemology, mineralogy, archaeometry, petrography, history of art, ancient history, sigillography, glyptics and cultural anthropology etc. Gemological, mineralogical and archaeometric papers related to engraved gem research are most welcome. English is the official language of the e-conference. Your lecture will be recorded during the conference and this record will be displayed in YouTube after. The e-conference is free of charge.

The so-called "Canon Tables" of the Christian Gospels are an absolutely remarkable feature of the early, late antique, and medieval Christian manuscript cultures of East and West, the invention of which is commonly attributed to Eusebius and dated to first decades of the fourth century AD. Intended to host a technical device for structuring, organizing, and navigating the Four Gospels united in a single codex - and, in doing so, building upon and bringing to completion previous endeavours - the Canon Tables were apparently from the beginning a highly complex combination of text, numbers and images, that became an integral and fixed part of all the manuscripts containing the Four Gospels as Sacred Scripture of the Christians and can be seen as exemplary for the formation, development and spreading of a specific Christian manuscript culture across East and West AD 300 and 800.

In the footsteps of Carl Nordenfalk's masterly publication of 1938 and few following contributions, this book offers an updated overview on the topic of "Canon Tables" in a comparative perspective and with a precise look at their context of origin, their visual appearance, their meaning, function and their usage in different times, domains, and cultures.

Dumbarton Oaks houses the largest collection of Byzantine lead seals in the world, with approximately 17,000 specimens. Volume 7 of the ongoing series of Dumbarton Oaks catalogues presents a distinct part of the collection: 572 anonymous seals bearing sacred images on both sides. The seals, almost all previously unpublished, are fully illustrated and accompanied by a detailed commentary that provides transcriptions of the identifying sigla. This volume represents the first attempt to analyze this group of seals chronologically and typologically.

The depictions of Christ, the Virgin, and a remarkably wide array of saints and narrative scenes offer rich and untapped material for scholars interested in Byzantine piety and culture. Discernible trends within this body of seals help to track the popularity of various saints and the changes in devotional images over time. The variety of these images, enhanced by reference to examples in other collections, will also enable scholars to compare the renderings of holy figures on lead seals to those appearing in other Byzantine religious images.

Cet ouvrage présente l'editio princeps, d'après les manuscrits IB 11.128-136 de la Biblioteca Nazionale Vittorio Emanuele III de Naples, et M 578 du Morgan Library and Museum de New York, de la version copte d'un grec transmis sous le titre de Discours sur le très beau Joseph. Ce Discours appartient au corpus de l'"Ephrem grec", qui regroupe un grand nombre de textes attribués à Ephrem le Syrien, dont la plupart sont considérés comme inauthentiques. Par son contenu, le Discours s'inscrit dans le cadre de la littérature juive et chrétienne relative au patriarche Joseph, qui développe les chapitres 37 et 39 à 50 du livre de la Genèse. Il ne peut toutefois être identifié à aucune autre production littéraire connue consacrée au patriarche. Par le nombre et la diversité des témoins qui l'attestent, le Discours sur le très beau Joseph est parfaitement représentatif des problèmes critiques posés par la transmission et l'édition de l'Ephrem grec.

Dear Colleagues,

We are making our best effort in keeping you informed on developments in the plans for the next International Congress of Byzantine Studies. If the current COVID 19 global pandemic crisis will substantially improve, the Congress, as agreed, is scheduled to take place in Venice - Padua on the 22-27 AUGUST 2022.

At the moment though, the current situation (as per November 2020) does not allow us to make further plans, and no contractor has been so far officially hired, in order not to waste resources should the Congress be further postponed.

However, what we can do is to start working on the structure of the program and define the new calendar for submissions of your contributions to the Congress.

As the Bureau of the AIEB has already made clear, the Congress will substantially keep the same program defined for Istanbul, with minor adjustments. In this sense, we are giving the opportunity to participants, should they so wish, to revise their proposals to take the new location of the Congress into account. This includes plenary sessions, round tables and free communications.

We ask you to submit a confirmation of your willingness to participate in the Congress and your revised proposal with the title/titles of contributions and name of participants by sending an e-mail to: [icbs2022@studibizantini.it](mailto:icbs2022@studibizantini.it).

The following cases may occur:

1) If you are a scholar who wants to offer a FREE COMMUNICATION, there is something new for you:

\*\*\*A) If you want to simply offer a free communication and you are fine to be grouped with other speakers, we will do it for you. You just send us the title of your paper and at least 5 keywords by APRIL 15, 2021.

\*\*\* B) If you want to offer a free communication, but you wish either to be inserted in the same group with other colleagues (e.g. colleagues you know already working on the same subject or on a subject that you feel is complementary to yours), or you want to present a research group (maximum 9 people and minimum 6 in 2 hours), you can do it. But be aware that in this case applies the rule that the group of scholars cannot include only people coming from one country, both according to the principle of nationality of the participants and of the country where they live: i.e., it is not possible to have a group composed, for example, by 5 scholars who either are all Italian (living in Italy or abroad) or work all in Italy (being Italian or not).

You just send us the list of participants (with their affiliations and nationalities), the titles of their papers and at least 5 keywords by APRIL 15, 2021.

This new format is planned especially for young scholars.

2) If your ROUND TABLE has been accepted by the Turkish committee: let us know by MAY 15, 2021 if you are still willing to organize and manage the round table you submitted and confirm the abstract of the round table together with the list of participants (with their affiliations) and the titles of their contributions.

Also in this case, if you wish so, you may change the topic of the round table to take the new location into account; however, this being the case, the Venetian-Paduan committee will have to examine the new proposal and discuss it with the international bureau.

We would also like to remind you that a round table should have a maximum of 6 and a minimum of 4 participants and that the group of scholars cannot be coming from only one country both according to the nationality of the participants and the country where they live: i.e., it is not possible to have a round table composed, for example, by 5 scholars who either are all Italian (living in Italy or abroad) or work all in Italy (being Italian or not).

3) If you have been invited by the Turkish committee to present a PLENARY SESSION PAPER: let us know by MAY 15, 2021 if you are still willing to give your paper and confirm your final title. Please notice that you may also change your topic to take the new location into account.

The deadline for submitting the final version of your paper for the proceedings of the congress is JULY 15, 2021.

### Doctoral Program

The doctoral program at MUSAPH is devoted to training future teachers and researchers in all areas of ancient Greek and Roman Philosophy, their medieval reception in Latin and Arabic, and textual criticism. Drawing jointly from LMU's Philosophy and Classics Departments, MUSAPH enables doctoral students to develop skills that each discipline brings to the study of ancient philosophy and offers the doctoral degree through both departments.

Established in the fall of 2010, MUSAPH is jointly directed by Professors Peter Adamson (Philosophy), Christof Rapp (Philosophy) and Oliver Primavesi (Classics). The regular teaching staff is rounded out by several additional faculty. MUSAPH also regularly invites guest faculty and visiting fellows to the program.

Aside from their dissertation work, doctoral students have the opportunity to participate in a very wide range of advanced courses, reading groups and workshops with leading scholars. Recent courses have focused on all periods of ancient philosophy, ranging from Atomism and Empedocles to Plotinus and Porphyry, but also the medieval reception of ancient thinkers in Latin and Arabic as well as their contemporary relevance. The methods employed in these seminars range from philosophical analysis to textual criticism. Thus, complementing our emphasis on philosophical breadth and rigor, MUSAPH gives doctoral students the opportunity to refine their knowledge of the classical languages and to do advanced philological work with ancient texts, including the authentication and editing of ancient texts. This broad spectrum of topics and approaches is reflected in the range of dissertation projects our doctoral students are currently pursuing.

Neither doctoral stipends, nor enrolment at MUSAPH, require teaching. Nevertheless many doctoral students will find it useful and stimulating to teach on occasion in the Classics or Philosophy Departments alongside their dissertation writing. There is in general ample opportunity for teaching and a great deal of flexibility regarding topics.

The doctoral program and doctoral fellowships are intended for students who are prepared to begin dissertation research immediately. These students will have, at a minimum, basic skills in Greek or Latin (and in some cases, Arabic) and a familiarity with the outlines of ancient philosophy; in most cases they will have gained a stronger background in languages or in philosophy with an M.A. or equivalent in Philosophy or Classics. Students who are not yet prepared to begin dissertation research might be interested in the Masters Program in Ancient Philosophy at LMU.
