## Zoom-Meeting

The title or the incipit of a book have always been a common means to refer to its textual content, leaving aside its material appearance. Yet, historical sources, like contracts, letters, and book lists of Jewish librar ies, to mention just a few, reveal a great variety of terms related to the material and visual aspects of the books, such as volumes, quires, scripts, bindings, etc. In this workshop, we would like to focus on the Heb rew and non-Hebrew terms used to describe Jewish manuscripts and printed books during the medieval a nd early modern periods. The inquiry into the terminology and the language of

book descriptions will help us to better understand the actual artefacts to which the terms refer and will shed light on the ways in which Jewish books were perceived and treated as material objects.

The main goal of the workshop is to provide a platform for scholars to exchange ideas and problems relat ed to the historical terminology of Jewish books, which hitherto has been not systematically investigated.

Oriental Manuscripts in Germany - Collection History Between the Academic Thirst for Knowledge, Antique Trade Across the Globe, and Imperial Claims to Power International Conference at the Berlin State Library, 29 June - 1 July 2022

International scholarship has recently intensified its focus on collection history, as current debates about Orientalism, colonial pasts, and provenance demand a more nuanced view on the processes that led to the transfer of knowledge contained in manuscripts from Asia and Africa to European libraries. The importance of the study of the development of collections in libraries and research institutions for understanding the history of the "Oriental disciplines" and intercultural relations is slowly beginning to be acknowledged.

During the past few years, digital databases have made Oriental manuscripts in Germany increasingly ac cessible while also bringing into focus collections of medium and small size. This enhanced visibility enabl es new perspectives on the historical development of these collections as well as on potential cross-connections.

# Topic area 1: Collection history

We welcome contributions that approach collection history from different perspectives. Not only institution s, but also agents, objects, a collection's reception, or its cataloguing process can serve as starting points for an investigation of the subject. Questions such as whether clear objectives or coincidences played a r ole in building a collection, handling the acquisition of scholars' libraries, or accepting donations will be of i nterest.

Closely related to collection research are matters of acquisition records, provenance documentation, and t he accessibility of such information in catalogues and databases, as well as their survey and analysis for r esearch on collection and provenance.

The call covers the entire range of African and Asian script cultures and also allows for contextualising Eu ropean manuscript culture. All time periods of collection will be considered. The focus is on developments in Germany in a broad international context.

## Topic area 2: Contexts

This area takes as its starting point social- and cultural-historical questions that go beyond the focus on a ctual historical collections. This includes market development on a global and local scale and its political a nd economic catalysts. The differentiation of the Oriental disciplines, scholarly networks, and development of scientific methods (including technological developments such as photography) present further factors that merit study as regards their impact on the development of collections and the market situation. To afford an objective assessment of the mechanisms of transfer of cultural assets from Asia and Africa, it see ms worthwhile to also consider antique trade in general and the dynamics of the European art market in p articular.

We welcome contributions on networks or individual agents of manuscript trade, different forms of manuscript translocation, and on the (virtual) reconstruction of historical collections.

From 20 to 24 September 2021, the Hiob Ludolf Centre for Ethiopian and Eritrean Studies organizes its Si xth Summer School in Ethiopian and Eritrean Manuscript Studies entitled "Introduction to the Study of Ge' ez Manuscripts".

#### Introduction

Ethiopia and Eritrea boast a rich and ancient (and living) manuscript tradition. Manuscripts are among the cornerstones of cultural heritage, both as means of communication, containers of texts and art, and as objects of material history.

There is no reliable figure for the total number of surviving manuscripts. For Christian Ge'ez manuscripts, the numbers are likely in hundreds of thousands: there are many thousands churches and monasteries in Ethiopia and Eritrea, each in the possession of at least several manuscripts, with biggest collections count ing several hundred codices. The number of historical - most valuable for researchers - manuscripts is di minishing at a quick pace. This underlines the necessity to record what has survived, and analyse the for m and the content of these witnesses of the centuries past.

Many of the achievements in Ethiopian and Eritrean manuscript studies from the last few years have been the result of work of scholars based in Hamburg, who have also successfully organized four Summer Schools, vastly appreciated by the students and young scholars of Ethiopian/Eritrean studies, Semitic studies, theology, and related disciplines.

The 2021 Summer School will be held online.

#### Aims of the school

The school aims at training graduate students and junior scholars in methods used in Ethiopian and Eritre

an manuscript studies. Lectures and seminars in topics ranging from History to Philology to Codicology to Cataloguing shall cover the most central aspects of research and help in developing skills necessary for t heoretical and practical tasks in the study of manuscripts. Much space shall be offered to discussion as w ell to group and individual excercises. Practical exercises will include codicological and philological description of manuscripts, palaeographic and art historical analysis.

The school focuses on Christian Ge'ez manuscript tradition. It is open to students and scholars of all disciplines, but some background in (Christian) oriental studies (not necessarily Ge'ez) is expected.

In connection with the Summer School, a practical training in digital humanities, TEI for Ethiopian and Erit rean manuscript cataloguing (three days, in the morning) shall take place, also online (via ZOOM).

# Participation

The Summer School shall be conducted in English.

The classes shall take place every day from Monday (Sept. 20) through Friday (Sept. 24), from 10 am to between 4 and 5 pm CEST.

In addition, four public evening lectures will take place between 5 pm and 6 pm CEST.

20 participants shall be selected on a competitive basis from all qualified applications that will reach us be fore the deadline (1 August 2021).

All students will receive a certificate of participation.

Throughout the centuries Byzantium's ambitious authors were conscious of the significance of literary registers for the reception of their texts. They deliberately made use of stylistic elements or refrained from using certain features in order to reach their target audience. There are certain groups of texts dating from various periods where these stylistic elements can be tracked precisely by comparison of two or even more versions with their model text. Such examples of rewriting can be found particularly within genres with a broader audience appeal, namely hagiography and historiography. It is in both genres that we encounter m

etaphrastic processes, in terms of stylistic elaboration and in terms of stylistic simplification.

As well as stylistic reshaping, metaphrasis may also encompass the addition or removal of literary and/or thematic aspects. All these processes signify intent as well as authorial interpretation. Frequently, the ide ological orientation of a text is refurbished through rewriting. Teasing out these strands for exploration hel ps to supply a potential wealth of information on the author (if known), cultural (social, religious, historical) context, and creative ability, as well as levels of education and literacy.

The previously unknown source of Book 3 of Cardinal Bessarion's In Calumniatorem Platonis:

Cardinal Bessarion's great defense of Plato, the "In Calumniatorem Platonis", written in response to Geor ge of Trebizond's "Comparatio Philosophorum Platonis et Aristotelis" and first published in 1469, was the first substantial statement of Platonism in the Plato-Aristotle Controversy of the Renaissance. Bessarion, however, had first written the In Calumniatorem a decade earlier, in 1459, without the massive Book III of the 1469 edition proving that medieval scholasticism supported Bessarion's interpretation of Plato and Ari stotle. With the discovery of the treatise Notata by the Dominican theologian Giovanni Gatti, we now know the source of Bessarion's new found erudition in medieval scholasticism. Bessarion initially attempted to i ncorporate Gatti's Notata whole cloth into the "In Calumniatorem Platonis", but in the end he exploited it as a storehouse of the scholastic references, quotations, and arguments, especially from Thomas Aquinas' writings, that made up the new Book III of the 1469 "In Calumniatorem Platonis". Thus, Giovanni Gatti's treatise played a major, though anonymous role in the Plato-Aristotle controversy for the rest of the Renais sance as Bessarion's work became in its turn a much used authority and source of information.

# The project

We are excited to recruit two postdoctoral research fellows to the project "The Early History of the Codex: A New Methodology and Ethics for Manuscript Studies (EthiCodex)" [https://earlyhistoryofthecodex.com]. The Early History of the Codex is funded by the Research Council of Norway (2021-2026) and managed by Brent Nongbri.

Professor of Ancient and Modern Greek and Latin Lund University, HT Faculties, Centre for Languages and Literature

Lund University was founded in 1666 and is repeatedly ranked among the world's top 100 universities. The University has around 44 000 students and more than 8 000 staff based in Lund, Helsingborg and Malmo. We are united in our efforts to understand, explain and improve our world and the human condition.

The Joint Faculties of the Humanities and Theology have eight departments and carries out large and vari ed work within research and education with the purpose to understand people as cultural and social being s. The faculties have around 700 employees and around 4000 students.

The Centre for Languages and Literature at Lund University (SOL) is Sweden's largest university departm ent for languages, linguistics, literature and area studies. SOL provides a wide range of freestanding cour ses complemented with an increasing number of first and second cycle degree programmes. Housing 33 subjects and roughly the same number of PhD programmes, SOL is a solid foundation for broad and dee p education and research, characterised by national and international visibility. SOL is managed by a boar d chaired by the Head of Department. The management also includes two assistant heads of department with special areas of responsibility. More than 250 people are employed and around 3 000 students, including around 100 PhD students, conduct their studies at SOL.

# On the subject and the content of the position

Since 2005, Ancient and Byzantine Greek has had a professorship at 50 per cent of full-time. The quantity and quality of the theses produced are of recognised high standard. Researchers in Ancient and Byzanti ne Greek frequently participate in international and Nordic contexts and have been successful in applying for external research funding. Recently, the focus has been on reception research, translation studies and Humanist Greek.

Modern Greek has an active research seminar. Lund University (LU) is the only one in the Nordic region t hat conducts research activities in Modern Greek. Researchers within the subject therefore collaborates w ith other disciplines at LU and with other higher education institutions, not least in Greece. The senior lect urers are responsible for managing a research journal with Byzantine and Modern Greek content and sup ervising linguistic and literary studies degree projects.

Latin has a high level of research activity and seminars with many external participants. The rate of these s submitted is also good. The researchers have an ongoing collaboration with Classical Archaeology and Ancient History, history of ideas, medicine and literary studies. Furthermore, the associate professor has in recent years participated in two major interdisciplinary projects at LU. Latin at LU strives to expand the interdisciplinary and interfaculty research collaborations.

#### **Duties**

As a research leader in the field, the professor's main duty is to lead research activities. The duties of a pr ofessor of Ancient and Modern Greek and Latin include responsibility for the development of research and education and training at PhD level, (individual research, planning, participation in, and management of, research projects including applications for research funding, and teaching, supervision and course devel opment in all cycles of study including at post-doctoral level. Active physical presence in the research environment is important.

The Greek language has a seamless continuity from ancient to modern Greek. The teaching at SOL cove rs this breadth and the professor will be responsible for research studies within the entire continuum. With in Ancient and Byzantine Greek, the professor will teach at all levels and supervise students and doctoral

students regarding their academic papers. In Modern Greek, the professor shall assist other staff member s in first and second cycle education and supervise doctoral students together with assistant supervisors. The professor is expected to develop joint seminars in Ancient and Modern Greek for research studies as well as joint courses at Master's level. In Latin, the professor must be able to teach first and second cycle education. The professor is expected to participate in Latin research seminars and, whenever needed, as sist the principal supervisor of Latin doctoral students.

## Required qualifications

A person who has demonstrated both research and teaching expertise shall be qualified for employment as a professor.

For appointment as a professor there is a requirement for training in teaching and learning in higher educ ation amounting to at least five weeks or that equivalent knowledge has been acquired in some other way

A successful candidate who does not speak Swedish, Danish or Norwegian at the time of appointment will be expected to acquire sufficient knowledge of Swedish to be able to use it as in a work context within two years of employment.

If the successful applicant has undergone fewer than 10 weeks training in teaching and learning in higher education and/or lacks training in the supervision of doctoral students, this training is expected to be obtained within the first two years of employment.
